#### **Position Summary:**

The Community Health Worker will build trust with and between community members, community agencies, and partners to engage participation the Minority Health Assessment Process. Responsibility includes leveraging relationships with local community-based organizations to identify and share community needs. The Community Health Worker will help to bridge communication and understanding between the community and public health and its partners.

#### **Essential Duties:**

Under the general supervision and/or as part of various workgroups and teams, the Community Health Worker/Health Coach performs the following essential functions within the framework of Panhandle Public Health District's provision of the core functions and essential services of public health:

Community Health Worker duties include:

- Bridge communication and understanding between the community and PPHD including translation as needed.
- Aid in community listening sessions, survey distribution and collection, and mapping.
- Develop work plan relative to the project goals.
- Become familiar with community and community resources.
- Complete self-motivated tasks and collaborate with teams while prioritizing workload and meeting deadlines.
- Comply with all reporting requirements.
- Actively participate in Performance Management and Quality Improvement activities.
- Participate in PPHD and community emergency response training and drills to support public health emergency and disaster preparedness consistent with job functions.
- Assumes responsibility for own professional growth and development by pursuing education, participating in professional committees and workgroups, and contributing to a work environment where continual improvements in practice are pursued.
- Performs other duties assigned.
- Follow and adhere to all HIPAA and PPHD confidentiality and privacy policies and practices.
- The core functions and essential services of public health.
- National public health accreditation standards.
