Area physician and business leader affirm their strong stance on getting the COVID vaccine

Dr. Bruce Forney, area physician, and Hod Kosman, CEO/President of Platte Valley Bank Companies joined the Monday briefing to share the importance of getting the COVID vaccine.

Dr. Forney has been a practicing physician in the Alliance and Gordon areas for nearly 45 years in August. His family ranch is in rural Sheridan county. He is concerned about the low COVID vaccination rate in the Panhandle.

“A recent local newspaper article shared a story of a young individual that’s been in the hospital for months showing how devastating the virus can be to even relatively young people,” Forney said. “While people believe this to be a disease of primarily older people, it’s not exclusive to them.”

He also shared the misconception that some believe about natural immunity to COVID but it is not necessarily better. Even if they have minor symptoms, the potential for long-term brain fog, difficulty thinking, and fatigue can be present for months afterward decreasing quality of life.

“Please think hard and get your COVID vaccine, the long-term symptoms are not fun to have,” Forney concluded.

The second guest leader, Hod Kosman, shared the unique strategies they’ve used with staff to increase COVID vaccination rates. Platte Valley Companies employs over three hundred people in the Nebraska, Colorado, and Wyoming areas.

“This virus was like nothing we ever experienced. In a normal setting, an employee may become ill and they were the only one affected by it while others kept operations flowing. With COVID, one person becoming ill impacts others. We had to close branches because we didn’t have enough people to man operations, that’s not a situation you want to be in,” said Kosman.

They took their promotion of COVID vaccines to employees seriously and it’s resulted in 100% of people over the age of 50 getting vaccinated with an estimated 50-55% of their overall employee population being vaccinated. They’ve offered two paid days off for anyone that gets their full vaccine series and later decided if they didn’t need the two days off, maybe they needed two extra days of pay. Once an employee got vaccinated, they could turn it into two

days of pay. If employees are willing to share their story on why they got vaccinated, they are highlighted in internal communications to encourage others.

“I encourage businesses to step up and do the right things to get their associates to be vaccinated. It’s really important. We need this to go away and go away now,” Hosman affirmed. “Personally, my family wanted to get together with kids and grandkids. We were not going to do that until we were vaccinated. This gave us the freedom and opportunity to go on a family vacation, the things that are important to get back to. I missed those kids so much. This is another good reason for people to get that shot so families can go where they want, when they want, and feel safe about it.”

The two steps are encouraged to ease the vaccine process. There is no charge for the vaccine. Pfizer will be coming soon to the Panhandle. Teens ages 16 & 17 can register at vaccinate.ne.gov.

People who are fully COVID vaccinated will not be required to quarantine due to close contact. If you have lost your COVID vaccine card, go to <https://tinyurl.com/2zh7uhhu>.

Three COVID deaths were confirmed, a Dawes County male in his 90s, Scotts Bluff County male in his 40s, and Sheridan County female in her 70s.

“We share our sympathy in the loss of our fellow Panhandle residents,” said Kim Engel, Panhandle Public Health District Director.

Unified Command confirms 19 more cases of COVID in the Panhandle since last reporting on Monday, May 3. The investigations are underway, all close contacts will be quarantined.
