Eleven COVID-related deaths in the Panhandle reported, Panhandle total deaths 42 Panhandle residents urged to celebrate upcoming holidays safely this year

The following COVID-related deaths in the Panhandle are being reported:

- Box Butte County female in her 80s
- Dawes County male in his 80s
- Grant County male in his 70s
- Kimball County male in his 60s
- Morrill County male in his 80s
- Scotts Bluff County:
 - Two females: one in her 60s and one in her 90s
 - \circ $\;$ Two males: one in his 60s and one his 70s $\;$
- Sheridan County: two females in their 80s

"We wish to express our sincerest condolences in the passing of eleven Panhandle residents. We send their friends and loved ones peace and comfort during their time of loss," expressed Kim Engel, Panhandle Public Health District Director.

The fall and winter holiday seasons are traditionally a time to gather with loved ones and celebrate. Participating in virtual gatherings or limiting celebrations to with those within your own household pose the lowest risk for COVID spread. Please help slow the spread of COVID and preserve hospital capacity.

If you choose to celebrate with people outside of your household, it is recommended to hold only small, outdoor gatherings and ensuring that attendees maintain a safe social distance.

If you plan to host or attend a small, indoor celebration: wear a mask, keep your distance, wash your hands often, and limit the number of people who handle and serve food.

Traveling increases your risk of exposure and the spread of COVID-19. The best way to prevent the spread of COVID this holiday season is to stay home.

- Avoid the Three Cs:
 - Avoid Crowded Places Avoid gathering in groups where you cannot maintain 6-feet of distance from others

- Avoid Close Contact Wear a mask over your nose and mouth or maintain 6-feet distance when you are spending more than 15 total minutes with people you don't live with
- Avoid Confined Spaces Avoid enclosed spaces with poor ventilation

Unified Command confirms 444 more cases of COVID in the Panhandle since last reporting on Monday, November 16. Recoveries are available on the Panhandle dashboard at <u>www.pphd.org</u>. The investigations are underway, all close contacts will be quarantined.
